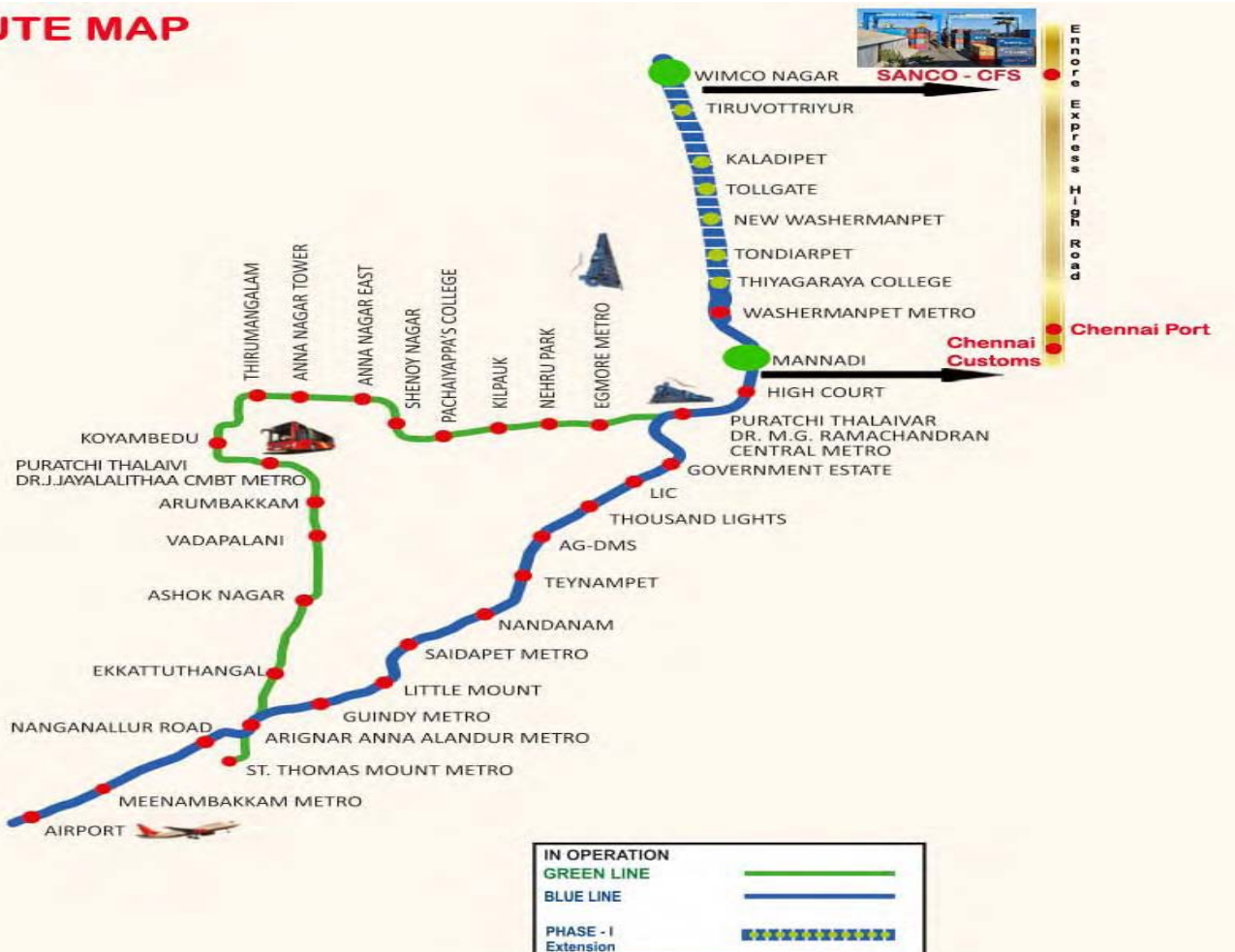


NETWORK OF **Sanco Trans Ltd.**

- As a Company we commenced our operations by providing Stevedoring and Port Operations for goods meant for Export and Distribution of Imported Goods from Port of Chennai.
- CONTAINER FREIGHT STATION (CFS) was set up in 1987, the first in India by a Private Sector organisation with Government Approval to handle Export Cargo.
- Air Cargo Division commenced in 1989. (International Federation of Freight Forwarders Association (FIATA) Member & International Air Transport Association (IATA) Member).
- CFS was accorded permission to handle import cargo from 1993 onwards.
- Container Yard was opened to store empty boxes and also to provide repair/service facilities.
- Steamer Agency operations commenced in 1980 for Bulk and 1996 for Container Lines.
- Terminal Operations with PSA Chennai & Adani Kattupalli was awarded based on our experience.
- Multi-Model Transport Operator (MTO) in 1997 to extend door to door service throughout the world.
- First Mile Delivery – (FMC) & Last Mile Delivery – (LMC) Business to Business (B-B)

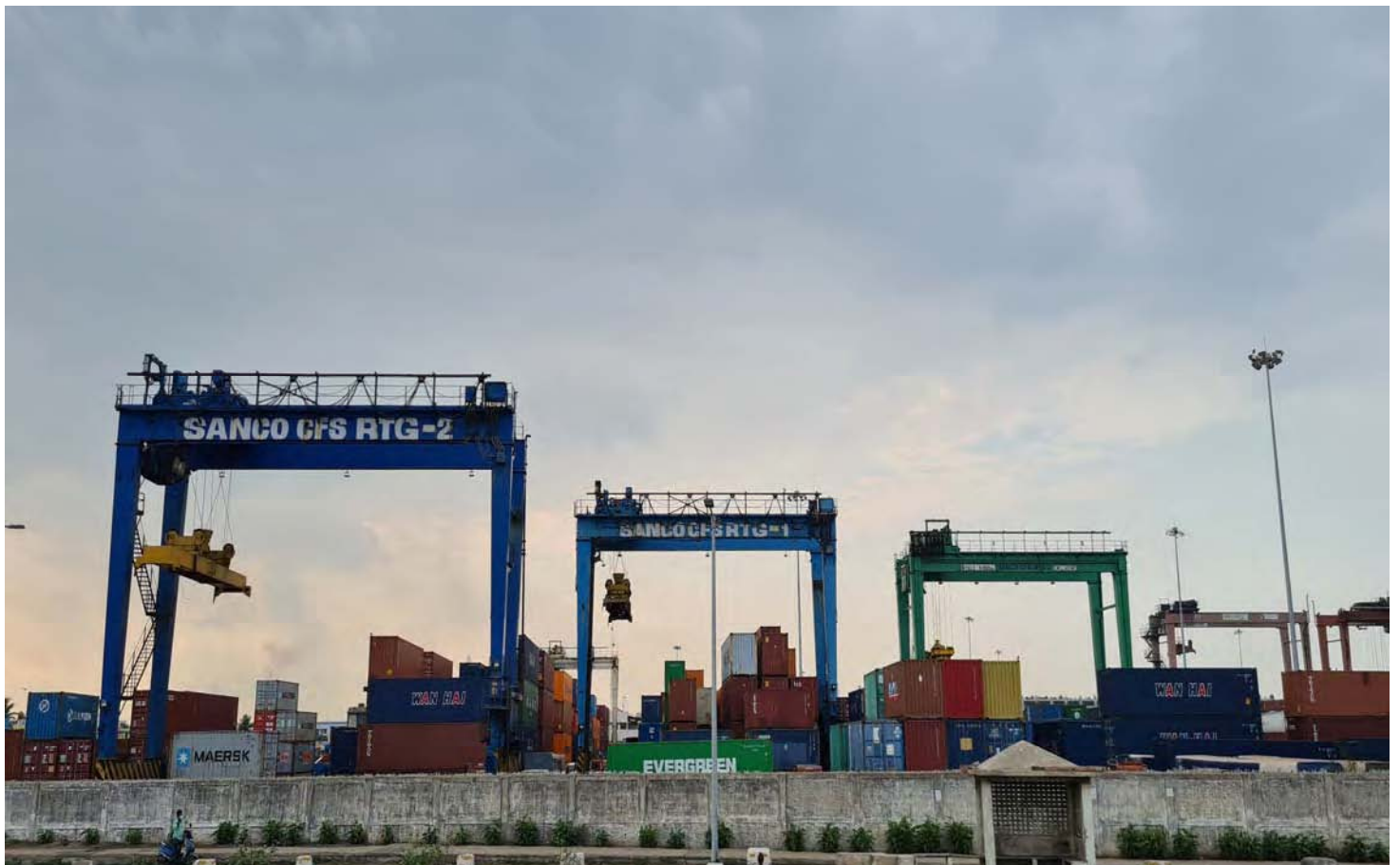

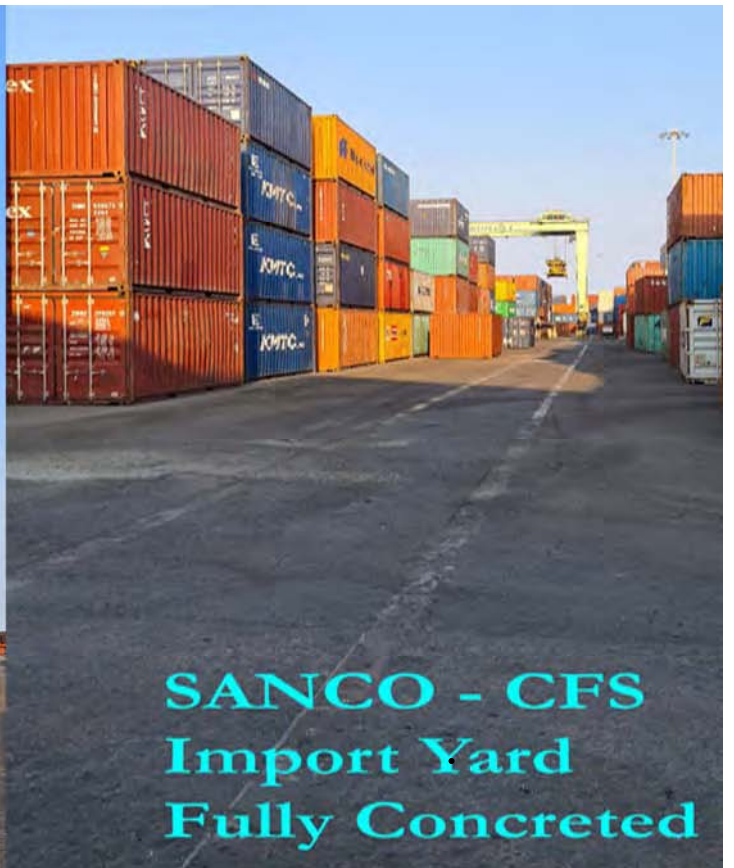
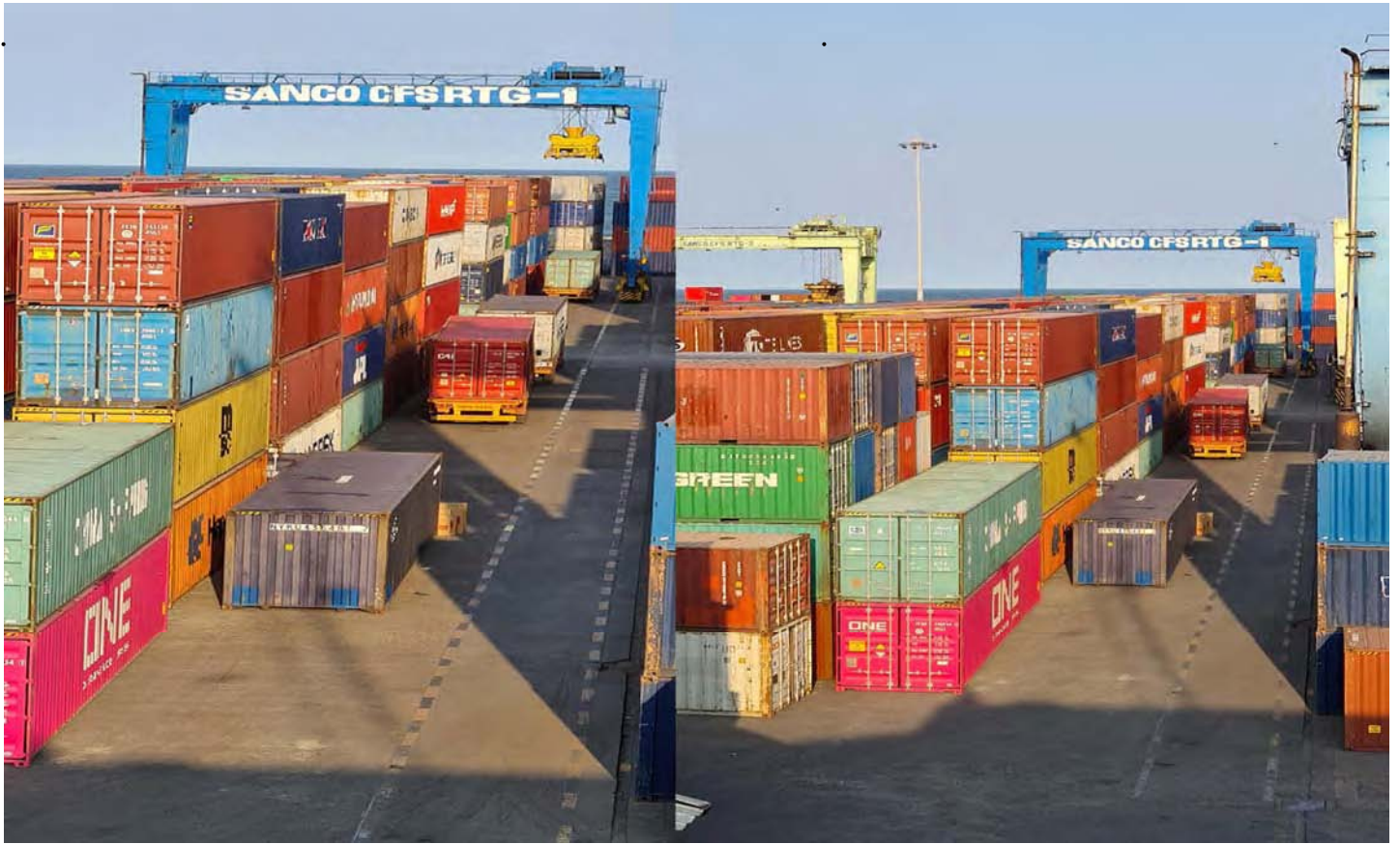

R.F.I.D. – CONTAINER TRACKING

RFID will enable the identification of containers over long distances and in demanding environments. This will help in real-time identification and tracking of containers, reaching new levels of traceability and control. Companies will know at any point in time, where their assets are and all movements at key locations will be recorded for eventual streamlining and optimizations.

Container Freight Station will issue a RFID tag for export container trailer with information such as vehicle number, driver name, shipping bill and supporting documents. On swiping, the RFID reader at the port entry displays all the information to the official at the gate for clearance.

Stevedoring & Break Bulk Operation

SANCO is one of the pioneer in stevedoring operations at chennai port for more than two decades. Licence for undertaking stevedoring operations at chennai port. For stevedoring operations. SANCO has got its manpower and also to handle bulk vessels with infrastructure facilities. Necessary equipment like Magnet, Grabs etc. for handling scraps, fertilizers, coaking coal, petroleum coke, sulphur, floursper, rock phosphate, Di-ammonium phosphate etc. are provided for effective output. Most of the operations will be unloading the bulk cargo from the vessel transporting to outside warehouse/the wagon/bagging and loading on the trucks.

We have handled bulk cargo like Fertilizers, Chemicals & Cooking coal for Power Sector for various Industrial units in and around Tamilnadu. We had also handled bulk shredded scrap for Steel Rolling Mills in and around Tamilnadu & Karnataka. On an average we had handled bulk cargo at Chennai Port to the extent of 1.00 lakh Mts. per year.

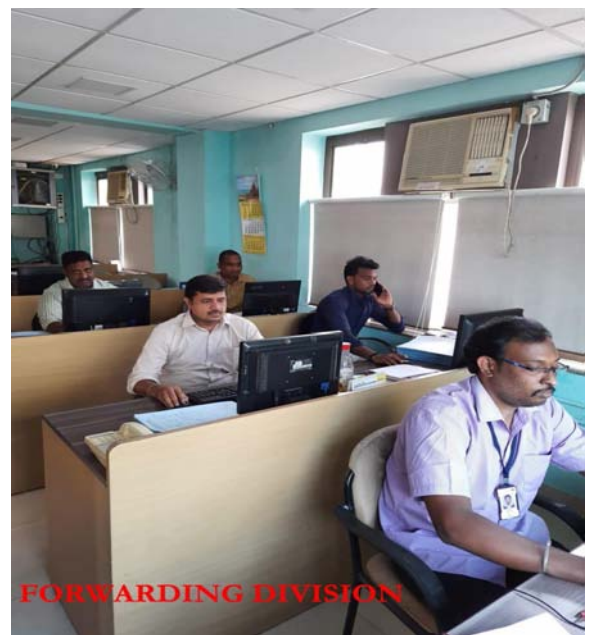

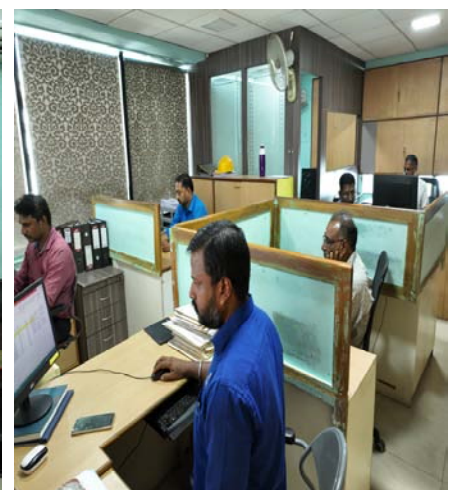
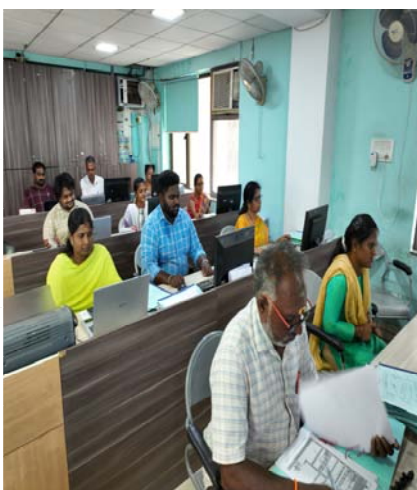
