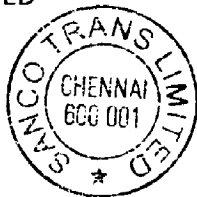

Summary of proceedings of 37th Annual General Meeting of M/s. Sanco Trans Limited held on September 18, 2017

The 37th Annual General Meeting of the Company was held on September 18, 2017 at 10.00 A.M. at Narada Gana Sabha, Mini Hall, No. 314, T.T.K Road, Alwarpet, Chennai – 600 018. Mr. V. Upendran, Chairman and Managing Director of the Company occupied the Chair and conducted the proceedings of the meeting.

The Chairman, after confirming that the quorum is present, called the meeting to order. Then, he introduced the Directors of the Company present in the dais viz., Mr. R. Vijayaraghavan (Chairman of Audit Committee and Nomination & Remuneration Committee), Mr. V. Shankar, Mr. R. Raghavan, Mr. T. R. Chandrasekaran, Mr. S. R. Srinivasan, Mr. S. Sathyanarayanan, Mrs. S. Devaki and Mr. U. Udayabhaskar Reddy. He also introduced Statutory Auditors and Secretarial Auditors of the Company.

Then he delivered his speech. The printed copy of the Chairman's speech was also distributed to the members present in the meeting.

The Chairman requested the members to take note that the Auditor's Report does not contain qualifications, observations or comments on financial transactions or matters, which have any adverse effect on the functioning of the company.

Then the Chairman invited comments and questions from the members.

Adoption of (i) the Audited Financial Statements of the Company for the year ended 31st March, 2017, the Reports of the Board of Directors and Auditors thereon; and (ii) the Audited Consolidated Financial Statements of the Company for the year ended 31st March, 2017 and the Report of Auditors thereon.

3. Re-appointment of Mr. S. Sathyanarayanan, Deputy Managing Director, who retires by rotation and being eligible, offers himself for reappointment.
4. Appointment of M/s. R. Sundararajan & Associates, Chartered Accountants, Chennai as Statutory Auditors of the Company and fix their remuneration.

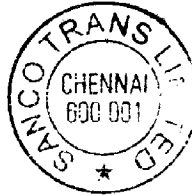
The Board of Directors had appointed Mr. Pankaj Mehta as the Scrutinizer to supervise the e-voting and ballot voting process.
